The gradual entry into force of the Multilateral Instrument has substantially modified the approach and the use of bilateral income tax treaties.

To the technical intricacies which are underlying this subject, is now added the hazardous exercise of integrating inputs of the Multilateral Instrument on a caseby-case basis.

Our panelists will review the practical details of these modifications through case studies applied to Switzerland, Luxemburg, and UK.

French real estate, often considered as prime target of the tax legislator, is however still attractive to French and foreign investors. The tremendous growth of parahostel and co-working activities over the past few years contributes to the significant benefits that they provide on the tax side.

Our team will review the multiple perspectives of this particular investment, which is at the crossroads of several legal and tax regimes. We will outline a crossboarding review of most of the taxes involved (corporate tax, income tax, VAT, transfer duties, etc...) supported by our experience gained from cases handled by our Boutique Law Firm.
